# Same Day ACH

In 2016 the National Automated Clearing House Association (NACHA) rolled out Same Day ACH rules. Prior to this change, moving money using the cost-effective ACH rails required a minimum one-day lead time. The adoption of Same Day ACH continues to expand year-over-year. Same Day ACH rules are periodically updated to meet evolving market demands and risk mitigation practices.

The latest improvement became effective in March 2020. The dollar limit for Same Day ACH transactions has been raised from \$25,000 to \$100,000 per recipient per day. This is true for both ACH credits and debits. The \$100,000 is truly per recipient; multiple payments on the same day, to the same recipient, totaling in excess of \$100,000 are not allowed.

## Paying or collecting from BUSINESSES or ORGANIZATIONS:

ACH type CCD - Commercial Collection or Disbursement (aka Cash Concentration or Disbursement)

- ✓ Direct payments to vendors
- ✓ Collecting payments from business customers
- ✓ Concentrating funds from your business accounts at other banks
- ✓ Sending funds to your business accounts at other banks
- √ Tax payments

#### NOT eligible for Same Day ACH:

- → International Transactions (IAT)
- → Transactions over \$100,000
